TERMS AND CONDITIONS OF TRADE

Claims: Goods must be inspected upon receipt. All claims or demands for defective merchandise must be made in writing within 5 business days of receipt of goods. Failure to give such notice shall constitute unqualified acceptance and waiver of all such claims by buyer. Written return authorization is required by seller for all returns. Any errors in items or price must be reported within 5 business days.

Purchased Items: All Paid items must be shipped within 14 days after payment. Failure to do so, may result in items being returned back to Pangea Home's Inventory, sold to others, and customer will receive a credit for future purchases.

Casualty: Buyer will ship products on its own freight carrier and at its own cost. Goods delivered through common carriers or sent via parcel post are at the risk of buyer. As a courtesy, Seller may provide and assist Buyer with freight carrier information, but this only a courtesy, and Buyer is not under any obligations to use such referred carriers. As such, Buyer cannot hold Seller liable for any freight damages that may result when using carrier information provided by Seller. Buyer shall conduct its own research and investigation prior to choosing a freight carrier. Buyer is responsible to make any and all freight damage claims with the common carriers and parcel post at its own time and expense.

Drop Ship Program: Pangea Home will drop ship items at the following rates: Items that need to be palletized are \$20 per pallet; items that ship via ground are \$5 per carton. Not all products can be drop-shipped. Pangea Home does not provide freight quotes for drop ship customers. All drop ship freight charges will be charged to the customer's freight account. Pangea Home does not prepay freight or process customer's freight claims. Pangea Home is not responsible for damaged freight or freight lost in transit.

If any action is instituted in connection with breaching this agreement, buyer agrees to pay any and all costs of collection, and litigation, including but not limited to attorneys fees, and interest at a rate of 1.5% per month.

Venue: This agreement shall be governed by and construed under the laws of the state of CA, to whose jurisdiction the parties do hereby submit. In the event that any action is instituted in connection with this agreement the parties agree that any action shall be commenced and maintained in Los Angeles County, California.
